Enkola ya PVoC mu Uganda etereddawo ekitongole ekivunanyizibwa ku mutindo gwe bya maguzi (UNBS) okukakasa omutindo no bulungi bwe byamaguzi ebi leetebwa, eri mu na Uganda abigula nokuziyiza ebicupuli, obyobulabe, n'ebintu ebitatuukaganye na mutindo okuyingira mu kajegere akasasaanya no kutambuza obusuubuzi.

Abayingiza ebyo busuubuzi mu gwanga betaaga okugoberela ebyetagisa bya PVoC okusobozesa ebyamaguzi byabwe okuyingira egwanga. Ebyamaguzi e biri munteekateeka no lukalala lwa PVoC byetaaga okubeera ne satifukeeti (CoC) ebikiriza nga e va mu nsi gyebabisuubude. Okulemelerwa okukola ebyo kuyinza okuleetawo okukeerewa okuyisa ebyamaguzi ate n'okuwa engasi ya bitundu 15% ku muwendo gwa (CIF) oba okuzikiriza ebyamaguzi nga nanyini kubileeta ya sasula oba okubizaayo mu nsi gyebyaava.

Mubyetaagisa bya pvoc mulimu

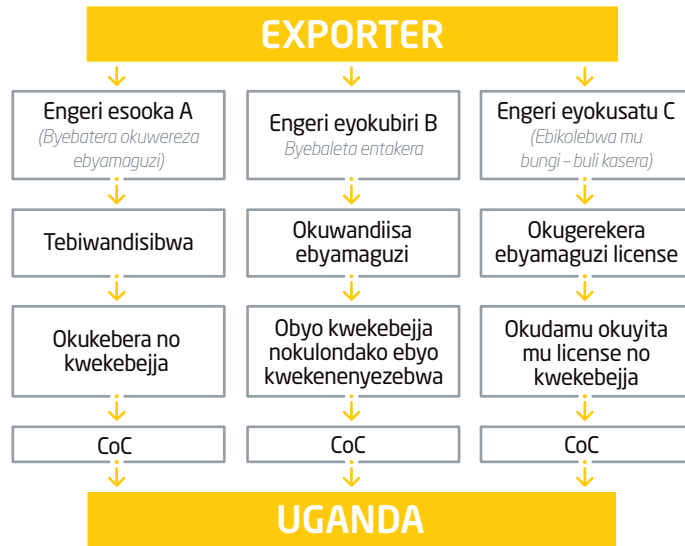
- Ebyamaguzi ebiletebwa nga biri ku lukalala olwagerekebwa mu PVoC byakuwerezebwa ne satifukeeti ebikiriza nga tebinatandika kutambuzibwa kubileeta mu gwanga.
- Satifukeeti ya PVoC yakuyamba kwangya bya misolo (customs clearance) gyabasuubuzi, nentambuza ya bya maguzi mu Uganda, no kukakasa nti ebya maguzi bino bikwatagana no buwayiro ne bilagiro byo mutindo ogwakakasibwa. Okulemelerwa okulaga satifukeeti kuyinza okuviirako okuwa engasi ya bitundu 15% ebya CIF ku muwendo gwe byamaguzi Byo.
